# COVID-19 Walsall College SAFEGUARDING AND CHILD PROTECTION POLICY UPDATE

As of 8<sup>th</sup> March 2021, students will be returning to Walsall College in line with the government's roadmap to cautiously ease lockdown restrictions in England.

The college will continue to have regard to the statutory safeguarding guidance Keeping Children Safe in Education (as amended January 2021).

During the current COVID-19 situation Walsall College continues to be passionate about safeguarding all students. We believe that not only do we have a statutory duty to ensure that we safeguard and promote the welfare of children and young people in our care, but also a moral duty.

Safeguarding and promoting the welfare of children and young people remains **everyone's responsibility**. Consequently, everyone who encounters our students, whether it is those in our settings during this period of lockdown or those students learning remotely, has a role to play in safeguarding and child protection. In doing so, all staff and volunteers should make sure their approach is child centred. This means that they should always consider what **is in the best interests of the child**.

The college continues to apply Keeping Children Safe in Education 2020 (amended January 2021) <u>https://www.gov.uk/government/publications/keeping-children-safe-in-education--2</u> during this period as well as the statutory guidance on inter agency working to safeguarding and promote the welfare of children, Working Together to Safeguard Children 2018 (updated December 2020) <u>https://www.gov.uk/government/publications/working-together-to-safeguard-children--2</u>.

Whilst the way the college is operating in response to coronavirus is fundamentally different to face-to-face safeguarding support, there are several important safeguarding principles that remain the same:

regarding safeguarding, the best interests of students must always continue to come first;

- if anyone in the college has a safeguarding concern about any student they should continue to act immediately;
- a Designated Safeguarding Lead (DSL) or deputy (DDSL) should be available;
- it is essential that unsuitable people are not allowed to enter the college workforce and/or gain access to students;
- students should continue to be protected when they are online.

We will take a whole college approach to safeguarding which allow us to satisfy ourselves that any new policies and processes in response to COVID-19 do not weaken our approach to safeguarding or undermine our Child Protection and Safeguarding Policy.

### Arrangement for vulnerable learners accessing their education

Vulnerable young people are those who:

- are assessed as being in need under section 17 of the Children Act 1989, including young people who have a child in need plan, a child protection plan or who are a looked-after child •
- have an EHC plan •
- have been assessed as otherwise vulnerable by educational providers or local authorities (including children's social care services) this includes:
  - young people on the edge of receiving support from children's social care services
  - o adopted children
  - those at risk of becoming 'not in employment, education or training' (NEET)
  - $\circ$  those living in temporary accommodation o those who are young carers
  - those who may have difficulty engaging with remote education at home (for example due to a lack of devices or quiet space to study) o others at the provider and local authority's discretion, including students who need to attend to receive support or manage risks to their mental health

Walsall College will continue to work with and support children's social workers to help protect vulnerable children and young people. This includes working with and supporting social workers and the Local Authority Virtual School Leads for those students who are looked after and previously looked after. Kit Rennie, Welfare and Safeguarding Officer will continue to coordinator this to ensure that all college staff receive the relevant information our looked after students. All Pastoral Support Officers continue to have access to ePEPs (on-line personal education plans) and can update and complete information when required.

There is an expectation that vulnerable children who have a social worker will attend an education setting, so long as they do not have underlying health conditions that put them at increased risk. In circumstances where a parent/carer does not want to bring their child to college and their child is considered vulnerable, the social worker and college will explore the reasons for this directly with the parent/carer. Where parents are concerned about the risk of the child contracting COVID19, the college or the social worker will talk through these anxieties with the parent/carer following the advice set out by Public Health England/Public Health Walsall. Walsall college will encourage our vulnerable children and young people to attend a school.

We know that all our student population will not be seen by college staff on a daily basis and therefore it is essential that every member of staff is observant in their contact with students and that they listen to the voice of the student to identify any emerging concerns regarding safety or mental and emotional health as well as their well-being.

It is important to note that some students will not have been 'at risk' previously but they become more at risk in this new COVID-19 context; the expected rise in students finding themselves homeless has increased already and it is important that we liaise with local partners through the new LA (local authority) measures to ensure that they are supported quickly. We have a statutory duty with regards to 16- and 17-year olds to provide information to local authority services to enable them to track and maintain contact with these young people. This will help local authorities to identify those not participating so that they can provide those students with the support they need to reach their potential.

College staff are encouraged and reminded to be particularly vigilant about new and additional safeguarding concerns. Staff have, and continue to be reminded about the safeguarding referral process and who they can contact in an emergency.

### Procedures for managing student safeguarding and well-being concerns

Now that students are returning to college and increasing face to face learning there is a safeguarding officer based each day at each college campus. The safeguarding email in-box continues to be monitored between 9am until 5.30pm each day - <u>safeguardingteam@walsallcollege.ac.uk</u> This ensures that any concerns received, either by college staff, professionals or the students themselves can be actioned immediately by a member of the safeguarding team. Staff are expected to send all student concerns to this email and not contact individual members of the safeguarding team.

In addition to safeguarding officers being based on all campus sites the Interim Head of Student Services and Wellbeing and Designated Safeguarding Lead, Andrea Packer is available every day and contactable via her email apacker@walsallcollege.ac.uk and by her mobile telephone 07917 628832.

All members of the safeguarding team have a work mobile to contact students directly each day who have been identified as vulnerable or at risk.

All contact and information regarding students continue to be recorded on the Safeguarding Casework area, and access continues to be only for safeguarding officers and volunteer safeguarding officers.

### Potential Absence of Designated Safeguarding Lead/Deputy DSL

There is an action plan in the event of different members of the safeguarding team being absent and how the service would be implemented. The Deputy Designated Safeguarding Lead, Luki Poonia is available in the DSL's absence via her email <a href="mailto:lponia@walsallcollege.ac.uk">lponia@walsallcollege.ac.uk</a> and by mobile telephone if necessary 07920 084602.

In the event of other members of the team being absent safeguarding presence on each campus will continue with some officers having to cover more times if necessary, taking on additional safe and well checks to ensure that all vulnerable students are contacted. Risk assessment methods to ascertain risk levels and priorities would be put in place if needed using a prepared method should such situation arise. Volunteer Safeguarding Officers would also support where they can.

Weekly contact is made with all members of the safeguarding team to check in and review work flow. A weekly safeguarding team meeting is held so that the Designated Safeguarding Lead is aware of any safeguarding risks or concerns. This information is shared with Jayne Holt, Assistant Principal to ensure that Senior Management is made aware at the earliest opportunity.

### Staff training and safeguarding induction

All existing college staff have received safeguarding induction training and on-line training for Keeping Children Safe in Education. Mandatory training for all staff was delivered in September 2020 covering Mental Health Awareness, Safeguarding, Keeping Students Safe on Line. Revised PREVENT training is now being delivered monthly to support staff managing concerns about possible radicalisation. Any new members of staff who begin their employment with the college during this time will continue to receive their induction and onboarding training on-line, which includes a face to face Level 1 Safeguarding Training with the Designated Safeguard Lead.

### Safer recruitment/volunteers

It remains essential that people who are unsuitable are not allowed to enter the workforce or gain access to our students. Walsall College will continue to the follow the relevant safer recruitment processes if we recruit new staff during this period adhering to part 3 of Keeping Children Safe in Education 2020 (updated January 2021).

Where the college utilises volunteers, they will continue to follow the checking and risk assessment process as set out in Keeping Children Safe in Education 2020 (updated January 2021).

Regarding members of the college workforce already engaging in regulated activity and who already have the appropriate DBS check, the college does not envisage that any members of the workforce will temporarily move to another college to support students and therefore that a new DBS check should be obtained.

The college will continue to follow its legal duty to refer to the DBS anyone who has harmed or poses a risk of harm to a child or vulnerable adult. Full details can be found in Keeping Children Safe in Education 2020 (updated January 2021).

The college continues to maintain the Single Central Record as outlined in Keeping Children Safe in Education 2020 (updated January 2021).

### Mental and emotional well-being

Negative experiences and distressing life events, such as the current circumstances, can affect the mental health of students and Walsall College is committed to support students and staff. The college is aware of how this situation may impact upon students where there is poor mental and emotional wellbeing and that this could escalate.

The college safeguarding area on our website includes information for our students who may seek support for their mental health and keeping healthy. Information has also been posted onto Yammer, our college social media platform as well as GOAL for students to access. The staff portal home page also includes information and useful website to access for mental health support. A weekly staff email includes information for staff about ensuring their emotional well-being currently and how to adjust to remote working from home. A weekly student newsletter also includes information about accessing support for emotional well-being and how to ask for a counselling appointment or safeguarding support.

### Online safety in college

Whilst students return to college and increase the amount of face to face learning, it remains a priority that the college continues to provide a safe environment for students to access the remainder of their learning from home. The college has set out clearly the platforms and methods for students to access their learning through a variety of mediums.

Appropriate filtering and monitoring systems continue to be in place to protect our students when they are online accessing work.

The <u>UK Council for Internet Safety provides information to help governing boards and</u> <u>proprietors assure themselves</u> that any new arrangements continue to effectively safeguard children online.

The <u>UK Safer Internet Centre's professional online safety helpline</u> also provides support for the children's workforce with any online safety issues they face.

It is important that all college staff who are interacting with students via the on-line learning platforms continue to look out for signs that a student may be at risk of that their wellbeing is declining, or that something has suddenly changed. Any such concerns will be dealt with via the <u>safeguardingteam@walsallcollege.ac.uk</u> email as detailed above, so that an appropriate response can be made and if necessary appropriate referrals made to the local authority partners.

The Department for Education has provided separate guidance on providing education remotely. It sets out 4 key areas to consider as part of any remote learning strategy. This includes the use of technology. Recently published <u>guidance from the UK Safer</u> <u>Internet Centre on safe remote learning</u> and from the <u>London Grid for Learning on the</u> <u>use of videos and livestreaming</u> could help plan online learning safely.

The college maintains that there is a starting point for online learning and teaching and that this must be the same principles as set out in the college Staff Code of Conduct and the E-communications Policy. These policies include amongst other things acceptable use of technologies, staff/student relationships and communication including the use of social media.

The Designated Safeguarding Lead continues to liaise with the Head of Human Resources Natalie Priest to ensure that college staff are regularly reminded about safe working practices with students at this time.

The college ensures that the use of any online platforms and systems are in line with privacy and data protection/GDPR requirements.

Students understand the reporting routes in place to raise any concerns when they are working on line, regularly information is sent out to students via email about how they can access learning safely and what to do if they are concerned.

The department encourages colleges to share this support with parents and carers, for example when self and well checks are made a reminder is given about the support available in college via the safeguarding team and the college counsellors. Pastoral Support Officers also speak with students and parents/carers to ensure that they are aware of the support available in college and how to report any concerns.

### Peer on Peer Abuse

The college recognises that during the closure a revised process may be required for managing any report of such abuse and supporting victims. Where our college receives a report of peer on peer abuse, we will follow the principles as set out in Keeping Children Safe in Education and of those outlined within our Child Protection and Safeguarding Policy. The college will listen and work with the young person, parents/carers and any multiagency partner required to ensure the safety and security of that young person. Concerns and actions will be recorded appropriate referrals made.

### **Domestic Abuse**

Walsall College staff are aware and stay alert to domestic abuse and that the potential for domestic abuse and violence to go unseen is high. We know that many victims will have reduced or limited opportunities to share what is happening to them. We are mindful that some young people, whether returning to college, or remaining at home,

will have suffered the impact of domestic abuse and we will be vigilant in our professional curiosity and ask those additional questions.

There are a range of resources available to support our students where they have been a victim of domestic abuse, including local support organisations as well as national ones.
